David N. Hoffman, JD is a health care lawyer and clinical ethicist in New York, where he is an Assistant Professor of Bioethics and core faculty member of the School of Professional Studies, Master's Program in Bioethics. David serves as the Chief Ethics & Compliance Officer/Hospital for the North Star Health Alliance, and as clinical ethics consultant to the VNS Health Hospice program.

Mr. Hoffman provides counsel to hospitals, medical facilities and individual practitioners in: governance, mergers, affiliations, medical litigation, bio-ethical decision-making and regulatory matters. He has also served on, and advises, ethics committees and institutional review boards. David's research focuses on the equal protection rights of clinicians and patients, as well as exposing pernicious myths about abuse of patients at the end of life.

Ann-Margaret Navarra, PHD, CPNP, FAAN is Associate Professor, Associate Dean, Nursing Research and Innovation at Stony Brook University. She also holds the position of Chair, Department of Doctor of Philosophy in Nursing Studies. Dr. Navarra is a triple alumna of Columbia University School of Nursing and earned her PhD in 2011 after many years of practice as a pediatric nurse practitioner. Prior to joining the faculty of Stony Brook University, she held the rank of Associate Professor with tenure at NYU Rory Meyers College of Nursing. She was a trailblazer in the early 1990's as one of the first advanced practice pediatric nurses leading care initiatives for youth living with HIV/AIDS. This pioneering work became the impetus for her major contributions to the HIV behavioral sciences and advancement of health equity for youth living with HIV. She demonstrated the need for expanded care models and developed and tested a novel and scalable cognitive behavioral technology-enabled intervention (Adherence Connection for Counseling, Education, and Support (ACCESS - K23NR015970; R01NR019535). Dr. Navarra's partnerships with the HIV and healthcare communities entail active collaboration with community health workers as integral members of her research and scholarship.

Dr. Navarra is a Fellow of the American Academy of Nursing, recipient of the 2021 ENRS/Nursing Research Authorship Award and gained recognition as Distinguished Alumni for Nursing Research at Columbia University School of Nursing. Most recently, She was selected as one of the first ten innovators for the Nursing Science Incubator for Social Determinants of Health (SDOH) Solutions (N-SISS) Fellowship through support from the Institute for Policy Solutions (IPS) at Johns Hopkins School of Nursing (JHSON), and the National Institute of Nursing Research (NINR). Presently she serves at the President-Elect of the Eastern Nursing Research Society (ENRS), a premier regional society directed to the advancement of innovative nursing science in the Northeast. Dr. Navarra seeks to improve health by educating members of congress on the impactful scientific contributions generated by nurse scientists in her role as an ambassador for the Friends of the National Institute of Nursing Research (FNINR).


